TERMS AND CONDITIONS

1. Eligibility

1.1 The "Trade & Win Monthly Lucky Draw" promotion ("Promotion") runs from 3 April 2017 to 30 June 2017, both dates inclusive.

1.2 This Promotion is open to all clients ("Clients") with a trading account with RHB Securities Singapore Pte. Ltd. ("RHB Securities").

1.3 Employees, trading representatives of RHB Securities and their immediate family members are not eligible to participate in this Promotion.

1.4 The Promotion consists of three (3) lucky draws ("Draws").

1.5 The qualifying period for each Draw (each, the "Qualifying Period") is as follow:

First draw: 3 April 2017 to 28 April 2017, both dates inclusive
